



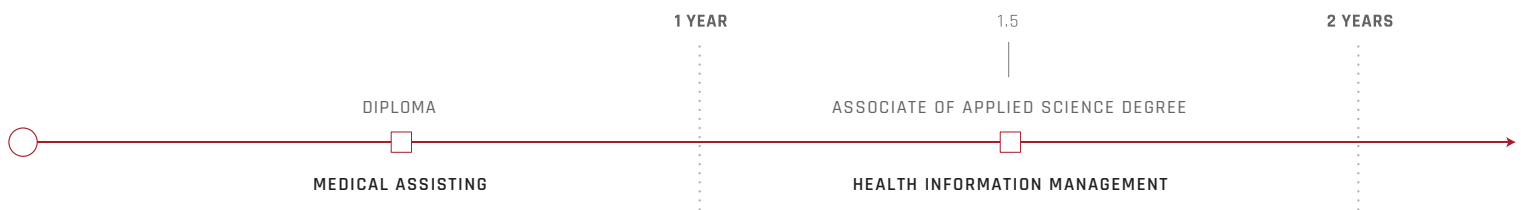
# HEALTH INFORMATION MANAGEMENT

## CONCENTRATION

Health Information Management is a combination of medicine, management, finance, information technology and law. Graduates of this program could choose to work in a variety of healthcare settings. Health Information Management professionals are trained in the latest information management technology applications and understand the workflow process. Duties could include operating computer information systems, coding diagnoses and procedures for reimbursement, maintaining quality control of health records, and more in accordance with strict state and federal laws.

The Health Information Manager is a vital member of the healthcare team and is responsible for managing these systems where the expanding arena of healthcare meets the cutting edge of technology. They are vital to the daily operation of health information and electronic health records.

At ECPI University's College of Health Science, you could earn your Associate of Applied Science Degree - Health Information Management in as little as 1.5 years through ECPI University's year-round program.

- ▶ Perform in the role of health information management technician by applying skills, values, and knowledge from the coursework to professional practice experiences.
- ▶ Demonstrate skills that are critical to adherence and promotion of continuous quality improvement, regulatory requirements, and the revenue cycle processes.
- ▶ Distinguish the legal and ethical standards of practice for health information management, including HIPAA, in a variety of health care settings and situations.
