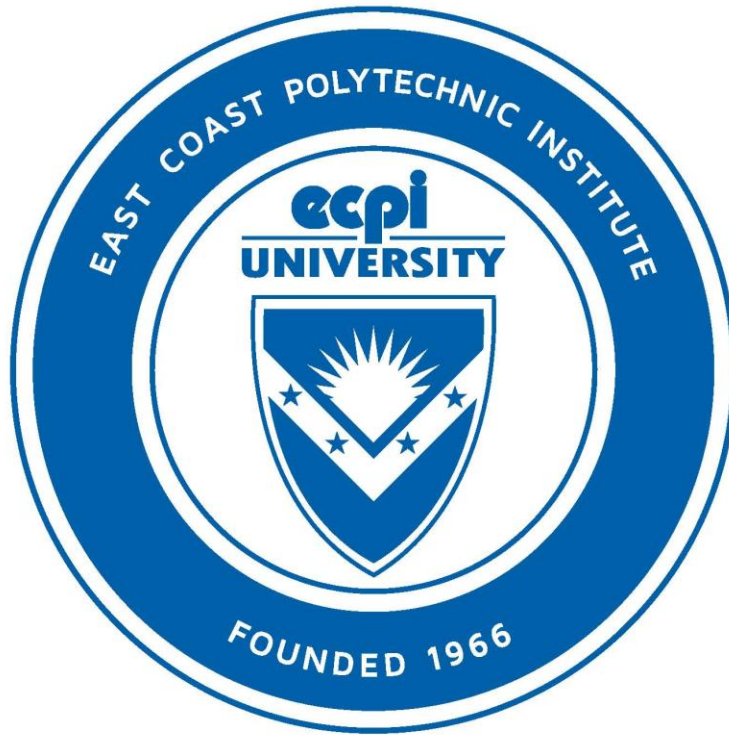

## 1.2 Admissions Guidebook Disclaimer

The admissions guidebook is a living document and is updated annually at minimum. The new academic year admissions guidebook will be published every January. ## 1.3 Selection Process

### 1.3.1 Who We Look For

When evaluating physician assistant candidates, we seek individuals who demonstrate a blend of academic excellence, quality life and direct patient care experience, and a drive to give back to their community. Ideal candidates possess a strong foundation in the sciences, have practical and genuine understandings of patient care and can demonstrate through their application an ability to connect, communicate, and work with others in a professional environment.

To assist candidates in evaluating their metrics for our program we have listed our assessment factors below\*:

1. Academics – Competitive applicants will exceed the minimum academic standards and will be given more consideration.
  - a. Prerequisite GPA
  - b. Undergraduate Science GPA
  - c. Undergraduate Overall GPA
  - d. Post-Baccalaureate GPA (will evaluate the last thirty credits)Additional points are given for GPAs above 3.0 in increasing value.

2. Life Experiences –
  - a. Personal Challenges

Socioeconomic factors:

1. [Family / personal income level](#) – as reported in CASPA
2. First-generation status
3. Raised in a medically underserved area as [highlighted by the HRSA](#).

- b. Community Involvement Post-High School

Extra-Curricular or community improvement activities. Criteria the admissions committee looks at:

1. If the activity had over 9 months of involvement
2. If the activity benefited underserved populations
3. Total number of activities

3. Non-Traditional Student. Non-traditional students to us are:
  1. Military/veteran
  2. At least 2 years post-undergraduate

3. Graduate of a master's program
4. Hampton Roads local preference (counties in VA and NC within a 75-mile radius)
5. Direct patient care experience – Our minimum criteria is 500 hours of direct care experience, but competitive applicants will have over 1200 hours of direct patient care experience.
  1. Clinical and healthcare licensures – additional points will be given to those with clinical healthcare licensure.
  2. Additional points will be given to those with over 500 hours of direct patient care experience and even more points will be given to those with over 1200 hours of direct patient care.

\* Interviews are required – see section 4.0 for details.

## 1.4 Program Mission and Goals

### Mission Statement

The Physician Assistant Program will provide a challenging and innovative academic setting for students from diverse backgrounds to become physician assistants. Graduates will provide exceptional healthcare, promote health equity, commit to personal and professional growth, and lead in the communities they serve.

### Goals

1. Provide a challenging and innovative learning environment where students gain the knowledge and skills necessary for entry-level PA practice.
2. Prepare graduates to practice in various settings and with various healthcare professionals to reflect the versatility and team-based nature of the PA profession.
3. Attract a cohort of students who will promote diversity in the PA profession.
4. Prepare students who are committed to personal and professional growth.

## 1.5 Technical Standards

### **Observation and Sensory Abilities**

Applicants and students must possess sufficient sensory capabilities to observe and assess patients accurately. This includes the ability to:

- Observe demonstrations, experiments, and waveform readings.
- Use vision, hearing, and somatic senses to assess patients at both close range and distance.
- Distinguish tissue texture, and symmetry/asymmetry.
- Integrate sensory information to make appropriate clinical decisions.

### **Communication Skills**

Effective communication is essential for accurate data collection, patient care, and collaboration with the healthcare team. Students must:

- Communicate clearly and effectively in spoken, written, and electronic formats.
- Elicit and convey patient histories, document data, and interpret findings accurately.
- Perceive and respond to nonverbal communication cues from patients and colleagues.
- Engage in empathetic, culturally sensitive communication to establish rapport.

### **Motor and Tactile Skills**

Students must possess adequate motor and tactile abilities to perform essential diagnostic and clinical tasks, including but not limited to:

- Performing physical examinations, including palpation, auscultation, and percussion.
- Conducting procedures such as suturing, lumbar punctures, and assisting in surgery.
- Providing emergency interventions like cardiopulmonary resuscitation (CPR).
- Maintaining stamina to handle physically demanding workloads in classroom and clinical settings.

### **Cognitive and Intellectual Abilities**

The program requires students to demonstrate cognitive abilities that ensure effective clinical reasoning and decision-making. Students must:

- Assimilate and integrate complex medical information from lectures, readings, and clinical experiences.
- Retain, analyze, and synthesize information to form diagnostic and therapeutic plans.
- Exhibit critical thinking, problem-solving, and the ability to make sound judgments under pressure.

### **Behavioral and Professional Attributes**

Emotional stability, resilience, and professionalism are critical for effective practice as a PA. Students must:

- Demonstrate integrity, empathy, and compassion in interactions with patients and the healthcare team.
- Maintain composure and professionalism in high-stress or rapidly changing situations.
- Exhibit self-awareness, seek feedback, and engage in continuous self-improvement.
- Adhere to ethical standards and respect diverse cultural and social perspectives.

The PA Program complies with the Americans with Disabilities Act and provides reasonable accommodations to qualified individuals. Students are encouraged to contact the Campus President to discuss their needs and initiate the accommodations process. ## 2.0 General Information

### 2.1 Program Quick Facts

1. Master of Science in Physician Assistant degree (MPA)
2. 24-month program
  - a. First year “Didactic Phase, is 12 months long with in-person instruction on campus.
  - b. Second year in “Clinical Phase” (full-time hands-on experiential learning)
    - i. Typically, 1:1 with physicians or PAs at the clinical sites
    - ii. Settings for clinical rotations:
      1. Surgery
      2. Family Medicine
      3. Internal Medicine
      4. Adult Specialty Medicine
      5. Emergency Department
      6. Pediatrics
      7. OB/GYN
      8. Behavioral Health
      9. Elective
      10. Preceptorship
    - iii. The PA program is partnered with the following sites for clinical rotations:

3. Credit hours:
  - a. Didactic year – 70
  - b. Clinical year – 51
  - c. Total program - 121 credit hours
4. Applications will be received nationwide through the Centralized Application Service for Physician Assistants (CASPA). Requires a bachelor’s degree from a regionally accredited college or university
  - a. Required GPA of 3.0 or higher.
  - b. Pre-requisites (see Admissions Guidebook Section 3.4 “Prerequisites”)
  - c. Minimum of 500 direct healthcare experience hours required.
5. Students will often re-locate to the area during the program.
6. Employment during enrollment in the program is highly discouraged.
7. Cohort size of around 50 students
  - a. The program does not have an option for deceleration or pauses.

## [2.3 ECPI University Facilities and Student Services](#)

During the didactic year students will practice clinical skills in classrooms located at the Virginia Beach campus. Students will have access to Anatomage tables for virtual dissections, dedicated clinical skills laboratory, an interprofessional simulation space including an intensive care unit (ICU)/trauma bay, and history and physical examination labs.

Students will also have access to our newly renovated on-site library, and virtual library services.

Students who need mental health resources, counseling, or accommodation can access these resources through the University wellness partner, WellConnect.

## [2.4 Advanced Standing and Transfer Credits](#)

The PA program does not accept previous medical training or experience for advanced placement. All PA matriculants are required to complete the full curriculum.

## [2.5 Citizenship, International Students, English as a Second Language](#)

We currently invite all international students who meet the established admissions standards to apply. \* However, international students, citizens, and U.S. students with an international degree must complete the following three additional requirements:

1. All academic transcripts from institutions outside the U.S. must be evaluated by a recognized credential evaluation service such as World Education Services (WES).
2. Those with English as a second language are required to submit TOEFL scores and meet the minimum requirement with [ECPI's TOEFL Standards and Requirements](#).
3. International students must also complete the additional steps outlined on the [ECPI International Student Admissions](#) page and send all documents to [isa@ecpi.edu](mailto:isa@ecpi.edu).

\*Foreign MD graduates must have a minimum medical school GPA of 3.0.

## [2.6 Background Checks and Drug Screening](#)

As a condition of enrollment and continued participation in the Physician Assistant (PA) Program, all students are required to undergo a criminal background check and urine drug screening prior to matriculating into the program. Students are responsible for all costs associated with meeting these requirements and must be approved through "Exxat Approve." Non-compliance with drug screening requirements, or a positive result without medical justification, may result in an offer of acceptance being rescinded.

## **3.0 General Admissions Requirements**

### **3.1 Application Timeline, Review Process, and Notifications**

April 24<sup>th</sup>, 2025, CASPA opens for 2026 Cohort  
September 2025 First Interview Invites Sent  
April 2026 CASPA Application Closes  
April 2026 Last Interview Invites Sent  
April – July 2026 Class Finalization and Waitlist Fill  
July 27<sup>th</sup>, 2026, First Matriculated Class Enters  
August 2028 First Class Graduates

Applications will be reviewed by the admissions committee based on academic performance, life experience, and healthcare experience. Selected candidates will be invited for an interview. These topics are graded via an internal rubric based on Sections 1.3.1 and 1.3.2 above.

We will contact all candidates via email with the following status/updates:

1. Notification of non-acceptance (application will not proceed forward)
2. Notification of interview invite
3. Notification of waitlist placement
4. Notification of conditional offer to matriculate

### **3.2 Centralized Application Service for Physician Assistants (CASPA)**

#### **3.2.1 Transcripts**

All transcripts must be uploaded into CASPA and submitted as part of the final application. If you have prerequisite courses or your degree is in progress, please upload them to CASPA as soon as they are completed and applied to your transcript. Interview invites and conditional acceptances will still be granted with courses in progress but will be rescinded if the prerequisite grade does not meet requirements or if a bachelor's degree is not conferred by the start of the program.

#### **3.2.2 Experiences**

Detail your experiences in the CASPA application. We do not accept updates to experiences after application submission unless there is a significant update to your experience that would enhance your chances of admission. Examples include finishing courses in progress, meeting minimum healthcare hours after application submission, etc. These updates should be tied to the criteria listed in "1.3.1 Who We Look For."

#### **3.2.3 Courses/Degrees in Progress**

We allow up to two prerequisites to be in progress during submission, but all prerequisites must be completed by Spring semester prior to matriculation.

### 3.2.4 Withdrawing an Application

## 3.3 Bachelor's Degree

All applicants are required to hold a bachelor's degree from a regionally accredited U.S. Higher Education Institution. International students and students with a degree from a foreign institution should refer to Section 2.6 in this manual for further guidance.

## 3.4 Prerequisites

### 3.4.1 Minimum and Competitive Standards, Required Prerequisites, Recommended Courses

Minimum standards are listed below. If you meet but do not exceed the "Minimum Required Standards" we still encourage you to apply as we review each applicant holistically based off the criteria in Section 1.3.2 "Who We Look For."

Competitive applicants will exceed the minimum required standards listed above.

#### **Required Prerequisites**

The table below outlines our program's specific prerequisite requirements.

\* Anatomy with Lab and Physiology can be taken as separate Anatomy and Physiology. They do not need to be a combined Anatomy and Physiology course.

\*\*Medical Terminology does not need to be completed from an institution of higher learning and can be taken online through Coursera or MedCerts. A certificate of completion must be submitted on your CASPA application or must be in progress at the time of your application submission.

### Three Self-Select Prerequisites

To increase the diversity of our applicant pool we allow students to “map” three additional prerequisites to their application. However, there are four requirements of self-select prerequisites:

1. Students must self-select 1x upper-level biology course, 1x upper-level chemistry course, and 1x upper-level math course.
2. At least one of the three self-selections must include a laboratory (in-person or virtual).
3. Each course must be at least 3+ semester hours.
4. Courses must be from a regionally accredited institution.

We will accept alternate courses for prerequisites on a case-by-case basis. Please contact PA admissions with:

1. Prerequisite Course
2. Substitution Course
3. Course description and credit hours from University Catalog

All GPAs will be reported by CASPA in accordance with the [CASPA value charts](#).

### 3.4.2 Online Courses

We currently accept online courses for core and prerequisite curriculum.

### 3.4.3 Pass/Fail, AP/IB, and CLEP

We currently accept P/F courses for core content classes only. All prerequisite courses must be passed with a letter grade of “C” or higher.

### 3.4.4 Grade Substitutions

Grade substitutions will be accepted for the highest grade completed for the course.

### 3.4.5 Prerequisite Time Window

All prerequisite coursework requirements must be taken within 10 years of enrolling in the program. For the 2025 admissions cycle, the oldest prerequisite we will accept will be from the Fall 2015 academic year.

## 3.5 Additional Testing

At this time, **we do not require** any additional testing except the TOEFL if applicable to you as outlined in Section 2.5. This means **we do not require** the following:

1. GRE
2. MCAT
3. CASPer
4. PA-CAT
5. Kira

If test scores are submitted, they will not be factored into our decision.

## 3.6 Healthcare Experience

A minimum of 500 hours of direct hands-on direct patient care experience is required, but competitive applicants will have over 500 hours of direct patient care experience.

1. Clinical and healthcare licensures – additional points will be given to those with clinical healthcare licensure.
2. Additional points will be given to those with over 500 hours of direct patient care experience.

A maximum of 100 experience hours may be volunteer/shadowing. This experience can be obtained through paid or volunteer work in healthcare settings such as hospitals, clinics, nursing homes, or other medical facilities. Acceptable roles include, but are not limited to, EMT, medical assistant, nurse, phlebotomist, and patient care technician hours can be in progress at the time of applying for the program but must be completed prior to matriculation.

### [3.7 Licenses and Certifications](#)

All licensing and certifications must be uploaded into CASPA. We do not accept them via any other delivery method.

### [3.8 Personal Statement/Essay](#)

The personal statement is uploaded to CASPA and must outline the applicant's motivation for becoming a Physician Assistant, relevant experiences, and career aspirations. We do not require an additional essay outside of the mandatory CASPA essays. However, we may include a short writing prompt on interview day for applicants who are invited to interview.

## [4.0 Interviews](#)

### [4.1 Interview Invite](#)

Interview invites will be sent to an applicant using the email provided on their CASPA application. Please add [PAAdmissions@ecpi.edu](mailto:PAAdmissions@ecpi.edu) to your contacts so that the invite is not filtered to your spam/junk folder.

### [4.2 Interview Day](#)

The interview day will consist of a brief presentation of the program, an introduction to key staff and faculty, and a facility tour. After a short recess, prospective students are interviewed through a multiple mini-interview (MMI) style process.

#### [4.2.1 Multiple Mini Interviews](#)

MMIs provide a more holistic assessment of the candidate, and multiple perspectives of the interviews help to reduce the impact of interviewer bias. Types of questions to expect in the MMI include, but are not limited to:

1. Ethical Scenarios
2. Teamwork
3. Communication Skills
4. Critical Thinking
5. Role-Playing

### [4.3 Candidate Status after Interview](#)

The admissions committee aims to make decisions no later than 2 weeks after the interview and will notify candidates through their CASPA email address with one of the following:

1. Notification of non-acceptance (application will not proceed forward)
2. Notification of waitlist placement
3. Notification of conditional offer

## **5.0 Interview Results**

### **5.1 Accepted Student Health Requirements**

Students are required to meet the health screening requirements to both matriculate and complete clinical rotations. Students must:

1. Have a physical examination by a licensed healthcare provider within six months prior to the start of the program
2. Have complete immunizations and boosters
  - a. *COVID-19*: Vaccination is not required by ECPI University for matriculation. Due to the evolving nature of these recommendations, the PA program encourages students to refer to the most recent [CDC recommendations](#) last updated October 31, 2024 for guidance. Note: Clinical year supervised clinical practice experience (SCPE) sites may have specific requirements for COVID-19 vaccination.
3. An annual TB screening
4. Provide proof of health insurance
5. Drug screening

### **5.2 Accepted Student Orientation**

New students will attend a mandatory orientation in July 2026, to receive welcome information, complete required paperwork, and meet staff, faculty, and other cohort members. This is mandatory for all matriculating students.

### **5.3 Deferment Policy**

Deferments will be granted on a case-by-case basis and will be granted for only one calendar year if approved. Please contact PA Admissions with your request and it will be sent to the program director for a final decision.

### **5.4 Deposit Policy**

Students who accept a conditional offer of admission are required to submit a nonrefundable \$1,000.00 deposit.

The ECPI University PA Program is currently seeking provisional accreditation from the ARC-PA. In the event that the program does not achieve Accreditation-Provisional status as planned, students will not matriculate and will receive a full refund of tuition and deposits. Please note this does not include fees paid by applicants to the Centralized Application Service for Physician Assistants (CASPA).

## **6.0 Accreditation Timeline**

Our current accreditation status and timeline are below:

July 24<sup>th</sup> – July 25<sup>th</sup>, 2025: Initial Provisional site visit with the Accreditation Review Commission on Education for the Physician Assistant (ARC-PA)

January 2026: ECPI University PA Program reviewed at ARC-PA January Commission Meeting

If provisional accreditation is granted:

July 27<sup>th</sup>, 2026: First Student Cohort Arrives

Spring 2028: Provisional Monitoring site visit from the ARC-PA

August 2028: First cohort graduates

Spring 2030: Final Provisional site visit from ARC-PA

**Definition of a developing program:** ECPI University has applied for provisional accreditation from the Accreditation Review Commission on Education for the Physician Assistant (ARC-PA). ECPI University anticipates matriculating its first class in July of 2026, pending achieving provisional accreditation status at the January 2026 ARC-PA meeting.

“Accreditation-Provisional” is an accreditation status granted when the plans and resource allocation, if fully implemented as planned, of a proposed program that has not yet enrolled students appear to demonstrate the program’s ability to meet the ARC-PA Standards or when a program appears to demonstrate continued progress in complying with the Standards as it prepares for the graduation of the first class (cohort) of students.
